In compliance with the requirement of section 3506(c)(2)(A) of the Paperwork Reduction Act of 1995, the

Centers for Medicare and Medicaid Services (CMS), Department of Health and Human Services, is publishing the following summary of proposed collections for public comment. Interested persons are invited to send comments regarding this burden estimate or any other aspect of this collection of information, including any of the following subjects: (1) The necessity and utility of the proposed information collection for the proper performance of the agency's functions; (2) the accuracy of the estimated burden; (3) ways to enhance the quality, utility, and clarity of the information to be collected; and (4) the use of automated collection techniques or other forms of information technology to minimize the information collection burden.

1. *Type of Information Collection Request:* New collection; *Title of Information Collection:* State Collection and Reporting of Dental Provider and Benefit Package Information; *Form Number:* CMS-10291 (OMB#: 0938—New); *Use:* Section 501 of the Children's Health Insurance Program Reauthorization Act (CHIPRA) requires the Secretary to work with States, pediatric dentists, and other dental providers to include, no later than August 4, 2009, on the Insure Kids Now (IKN) Web site, a "current and accurate list of all dentists and providers within each State that provide dental services to children enrolled in the State plan (or waiver) under Medicaid or the State child health plan (or waiver) under CHIP. Section 501 of CHIPRA also requires the Secretary to ensure the list is updated at least quarterly and includes the description of the dental services provided under Medicaid or CHIP and whether the services are provided through a State plan or waiver. The Secretary shall also post on the IKN Web site State specific information on available dental benefits. This information collection requirement will allow States to begin collecting the information on the dental providers and

dental benefits in accordance with CHIPRA. *Frequency:* Yearly and Quarterly; *Affected Public:* State, Tribal and Local governments; *Number of Respondents:* 51; *Total Annual Responses:* 255; *Total Annual Hours:* 9,180. CMS is requesting OMB review and approval of this collection by *June 26, 2009*, with a 180-day approval period. Written comments and recommendations will be considered from the public if received by the individuals designated below by the noted deadline below.

Title: National Survey of Child and
Adolescent Well-Being Second Cohort
(NSCAW II).

Description: The Department of
Health and Human Services (HHS)
intends to collect follow-up data on a
sample of children and families for the
National Survey of Child and
Adolescent Well-Being (NSCAW). The
NSCAW was authorized under Section
427 of the Personal Responsibility and
Work Opportunities Reconciliation Act
of 1996. The NSCAW is the only source
of nationally representative, firsthand
information about the functioning and
well-being, service needs, and service
utilization of children and families who
come to the attention of the child

welfare system. Information is collected
about children's cognitive, social,
emotional, behavioral, and adaptive
functioning, as well as family and
community factors that are likely to
influence their functioning. Family
service needs and service utilization
also are addressed in the data collection.

Selection of the current NSCAW
sample and baseline data collection
began in 2007 with a final anticipated
sample size of 5,700 children. The
proposed data collection will allow for
follow-up of this sample 18 months
post-baseline, and will follow the same
format as that used in the baseline
round and will employ, with only
modest revisions, the same instruments
that were used in the previous round.
Data from NSCAW are made available to
the research community through
licensing arrangements from the
National Data Archive on Child Abuse
and Neglect at Cornell University.

Respondents: Children and their
associated permanent or foster
caregivers, caseworkers, and teachers.

Title: Cross-Site Evaluation of the
Children's Bureau Grantee.

Cluster: Supporting Evidence-Based
Home Visiting Programs to Prevent
Child Maltreatment (EBHV).

OMB No.: New Collection.

Description: The Administration for
Children and Families (ACF), U.S.
Department of Health and Human
Services (HHS), is proposing this cross-
site evaluation data collection activity to
identify successful strategies for
adopting, implementing, and sustaining
high-quality home visitation programs

to prevent child maltreatment. An
evaluation study will address four
domains: (1) Systems change to develop
infrastructure, (2) fidelity to home
visiting models, (3) costs, and (4) family
and child outcomes (via a review of
grantee analysis reports). A process
study will focus on the broader grant
initiative to understand how programs
plan and develop the infrastructure
needed to support home visitation
services and how programs ensure
service quality.

Information will be collected through
biennial site visits, semi-annual
progress reports, and monthly entries
into a web-based data system. Site visits
will include interviews with key grantee
staff and stakeholders involved in the
execution of the grant and in the efforts
to make system changes. Progress report
cross-site evaluation data will capture
the costs of home visiting and provide
additional information on systems
change. Web-based data entry will
include EBHV program and participant
characteristics along with systems
change updates on goals and operations
every six months. Additionally, cross-
