Abstract: The purpose of the information collection is to gather data for the upcoming National Civilian Conservation Corps (NCCC) impact studies. The studies intend to assess the performance and impact of NCCC programs on members and communities served by the program. In particular, the studies will investigate three main components of NCCC:

1. The impact of NCCC on developing leaders
2. The impact of NCCC on strengthening communities
3. Retention at the different phases of the program, from application to completion

Comments submitted in response to this notice will be summarized and/or included in the request for OMB approval. Comments are invited on: (a) Whether the collection of information is necessary for the proper performance of the functions of the agency, including whether the information shall have practical utility; (b) the accuracy of the agency's estimate of the burden of the collection of information; (c) ways to enhance the quality, utility, and clarity of the information to be collected; (d) ways to minimize the burden of the collection of information on respondents, including through the use of automated collection techniques or other forms of information technology; and (e) estimates of capital or start-up costs and costs of operation, maintenance, and purchase of services to provide information. Burden means the total time, effort, or financial resources expended by persons to generate, maintain, retain, disclose or provide information to or for a Federal agency. This includes the time needed to review instructions; to develop, acquire, install and utilize technology and systems for the purpose of collecting, validating and verifying

information, processing and maintaining information, and disclosing and providing information; to train personnel and to be able to respond to a collection of information, to search data sources, to complete and review the collection of information; and to transmit or otherwise disclose the information. Instructions for Implementing Efficient Federal Operations Executive Order (E.O.) 13834

AGENCY: Council on Environmental Quality.

ACTION: Notice of Availability of Instructions for Implementing Efficient Federal Operations Executive Order (E.O.) 13834.

SUMMARY: The Chairman of the Council on Environmental Quality (CEQ) has issued instructions to Federal agencies for meeting energy and environmental performance requirements in a manner that increases efficiency, optimizes performance, eliminates unnecessary use of resources, and protects the environment, as required under Executive Order (E.O.) 13834, "Efficient Federal Operations," signed by President Trump on May 17, 2018. The purpose of the Executive Order is to direct agencies on the management of Federal facilities, vehicles, and operations to achieve statutory requirements, while prioritizing actions to reduce waste, cut costs, and enhance resilience of Federal infrastructure and operations for effective accomplishment of agency missions.

DATES: The Implementing Instructions for E.O. 13834, Efficient Federal Operations were issued on April 30, 2019.

Notice of Intended Disinterment

AGENCY: Department of the Army, DoD.

ACTION: Notice of intended disinterment.

SUMMARY: Army National Military Cemeteries (ANMC) is honoring the requests of six families to disinter the human remains of six Native American students from the Carlisle Barracks Post Cemetery, Carlisle, Pennsylvania. The decedent names are Ophelia Powless (aka Ophelia Powias), Sophia Caulon (aka Sophy Coulon), Jamima Metoxen (aka Jemima Meloxen), Henry Jones, Alice Springer, and Adam McCarty (aka Adam McCarthy). These students died in the 1880s and 1890s while attending the Carlisle Indian Industrial School. At the request of the closest living relative for each decedent, ANMC will disinter, transfer custody, transport, and reinter the remains in private cemeteries chosen by the families. This disinterment will be conducted in accordance with Army Regulation 210-190. This is not a Native American Graves Protection and Repatriation Act (NAGPRA) action because the remains are not part of a collection as they are interred in graves that are individually marked at the Carlisle Barracks Post Cemetery.

DATES: The disinterment is scheduled to begin on June 15, 2019. Transportation to and re-interment in private cemeteries will take place as soon as practical after the disinterment. If other living relatives object to the disinterment of these remains, please provide written objection to Mr. Thomas Mullen at the email address listed below prior to June 7, 2019. Such objections may delay the disinterment for the decedent in question.
